## **Dealing with the Times**

We are in unprecedented times right now. Fewer games are being played this fall, entire

tournaments are postponed, games are cancelled last minute, fields are moved last minute.

With all the uncertainty about fall sports we ask that every referee, assignor, assessor and instructor be flexible and understanding. You may get a call at the last minute because your game got cancelled. You may find out that you can't work the rest of a tournament because a team you refereed was exposed to COVID. You may be asked to go to a different field while driving to your game. You may lose game fees because you are not able to work a game.

We know it can be frustrating. Those decisions are made on a case-by-case basis and are made to protect everyone's health and safety. There are no easy or right answers. Each assignor has their own contract with the league or tournament and will work with them as situations arise.

We are all in this for the players.

### 2021 Recertification

U.S. Soccer has provided the option for State Referee Committees (SRCs) to extend registration for all 2020 licensed referees through 2021 at no additional charge. EPSARC has decided to opt-in to this decision. Therefore, we will be issuing all 2020 license holding referees the same license for 2021 at no additional cost. This applies to all assignors, assessors and instructors.

As a referee, you will need to complete the steps below to remain in compliance for 2021:

- Ensure your background checks are clear and up to date
- Ensure you have completed SafeSport and that the completion certificate is still active
- Complete the Laws of the Game online refresher course modules.

Information and details on how to complete the above steps and recertify for 2021 will be posted on our website.

We hope that this decision helps alleviate some of the challenges our community is currently facing. Your active participation within the soccer community is crucial to our continued goal of growing and improving the sport and we appreciate your continued involvement and support.
