

# Eastern Pennsylvania Soccer Association Referee Program

## Entry Level Hosting Requirements

October 2023

---

Organizations interested in hosting an entry level referee clinic must adhere to all requirements below.

### To successfully complete the Entry Level Course, Referee Candidates must:

- Complete Online lessons
- Attend an in-person session
  - In-person sessions will consist of 3 hours of classroom and 3 hours of on field training
- Complete appropriate background clearances

### To host an Entry Level Field Session:

1. **Sponsoring Organization appoints a Representative**
2. **Entry Level referee sessions will be hosted:**
  - i. Between 3<sup>rd</sup> weekend in March and 3<sup>rd</sup> weekend in November if field portion will be outside.
  - ii. Any time of year if the field portion will be indoor.
3. **Representative obtains a Classroom and a Soccer Field**
  - a. **Classroom/Indoor Room**
    - i. Must be available the week prior to or the same day as the Field session.
    - ii. Must be able to accommodate up to 30 students
    - iii. Must be available for 3 hours
    - iv. Must have a room with electricity to hook up audio/visual aids (projector or laptop provided by EPSARC) to a screen or wall.
  - b. **Soccer Field or Large Gym (indoor locations may be used upon approval)**
    - i. Field should have proper goals and field markings
      1. Field may be full size or small-sided, outdoor or indoor
    - ii. Field must be available for 3 hours
      1. May be on any day at any time (after the classroom or the same day as)
    - iii. Proof of field reservation may be required to avoid conflicts with other facility activities
    - iv. Bathrooms or port-a-pots must be available for participants
  - c. **If classroom and field sessions are on the same day, and both facilities are available**, the option of moving back and forth between the two locations during the 6 hours may be utilized.
4. **Representative submits a Host Request to EPSARC**
  - a. [Application to Host](#)
    - i. Must be received a minimum of 30 days prior to the requested date
    - ii. Requests will be reviewed in the order in which they are received
    - iii. Upon approval, Field Session will be available for Referee Candidate registration via their account in EPSARC.org

### iv. Enrollment

1. Maximum # of Referee Candidates: 30
2. Minimum # of Referee Candidates: 10
  - a. A Field Session may be cancelled if the minimum # is not achieved

### 5. Referee Candidate Entry Level Registration

- i. Fee - \$110.00
- ii. Register via EPSARC.org
- iii. Upon registration, each Referee Candidate will enroll in the Online Lessons clinic.
  1. Registrants will complete the online lessons
  2. Once lessons are done, they will pick a Clinic to transfer to.
  3. [Background clearances](#) must be received before a person can be approved as a referee, although they're not required for attendance at the clinic.

### 6. Inclement Weather/Field Conditions

- a. In the event of inclement weather (lightning, severe rain, snow) or field closure due to unsafe or extenuating conditions, the Field Session will be rescheduled.
  - i. A new Host Request form must be submitted
  - ii. In the event a candidate cannot attend the rescheduled field session, they will receive credit to attend another upcoming clinic.

### 7. Representative **MUST** be present at the beginning of each session (does not need to stay)

- a. Ensure the accessibility of the classroom and reserved field
- b. Meet the Lead Instructor
  - i. Ensure bathrooms, parking, etc. are all accessible.

### 8. Referee Candidate Field Session Participation

- a. Referee Candidates should arrive to the Classroom and Field Session properly equipped as a referee
  - i. Uniform- shirt, shorts, socks
  - ii. Whistle, referee wallet, yellow card, red card, flags

  - iii. Candidate must be present for the full duration of each
